The customer license accounting service begins with the implementation process of Microsoft Dynamics 365 Business Central. To purchase a license from Microsoft, you need to use an authorized Partner Center. **getsix® Services** has had the necessary qualifications and experience in this type of implementation for many years. **License purchase and configuration stage** usually lasts from 3 days to about 2 weeks, depending on the speed of communication and the number of users requiring the configuration. REDUCING ACCOUNTING COSTS

Outgoing invoices will be created directly in the accounting system, so the accounting office will not charge you extra for manually entering documents into the accounting system. In the future, it is likely that incoming invoices will also be able to be pulled directly from KSeF into the accounting system, so you will avoid having to complete and send incoming invoices.

REAL-TIME REPORTING

The system is prepared in such a way as to fully support the management of the company, among other available reports. One of the most popular reports used by our customers is the open items report. It shows the company's accounts receivable balance as of a specific date set by the user. It tells what documents, and for whom issued, have not been paid so far. This is the basis for further action - for example, monitoring of receivables, debt collection, judicial enforcement of claims. Another frequently used tool are analytical worksheets that allow generating reports, e.g. on sales of services according to location or other selected factor, or cost breakdown by place of formation, etc. Data from the system can also be analyzed by creating individual account sheets or from predefined, ready-made sheets that are standard in the system. The multidimensionality of these sheets allows comparing numerical data from different periods and accounting accounts, in the context of the dimensions set by the user. There are as many as 8 levels of dimensions in the system.


BOTH THE DATA AND THE SYSTEM ARE OWNED BY YOU

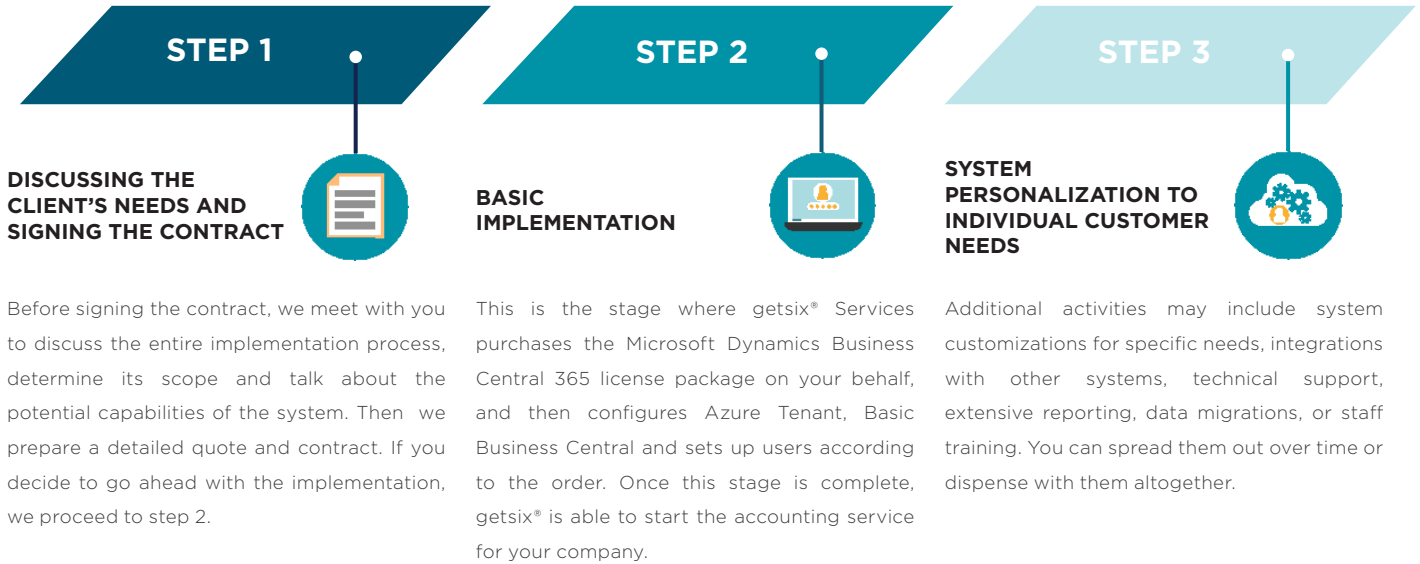
